# ADDITIONAL INSTRUCTIONS TO THE BIDDERS

(To be attached with Technical & Commercial Part)
(Over & above the existing instruction)

The tender notice and tender document/specifications BOQ shall remain available at website www.rpeace.ac.in during the tender notice period and the same can be downloaded and used as tender document for submitting the tenders, However the cost of tender forms mentioned in the tender notice has to be paid in the form of DD drown in favour of undersigned payable at Executive Engineer (Civil)-II, IDA Project, Dr. RPCAU, Pusa to be enclosed with the tender form while submitting the tender.

In case the tender submitted in downloaded form is not accompanied with valid DD towards the cost of tender document/ specifications/ BOQ with technical and commercial part I, the tender will be summarily rejected.

The tenderers, who will be found indulging in changing/ adding or deleting the contents of the downloaded tender document/specification/BOQ will be liable to face necessary action including banning, suspension from business dealing etc.

- 2. Tenderers should watch the website for Corrigendum Addendum to the NIT/ Tender Documents and there will not be any separate correspondence about the same.
- 3. Tenderers should submit in original downloaded documents duly signed and stamped on each page. Any photocopy or typed copy of the downloaded document will be treated as invalid.
- 4. Demand draft furnished towards the cost of tender document/ specifications/ BOQ in case of downloaded documents, shall be verified before bid evaluation.

# Eligibility Criteria.

- 1. Average Annual financial turn over during the last 3 years, ending 31<sup>st</sup> March of the previous financial year should be at least 30% of the estimated cost.
- 2. Experience of having successfully completed similar works during last 5 years ending last day of month previous to the one in which N.I.T's are invited should be either of the following:-
  - (a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost.



(b) Two similar completed works costing not less than amount equal to 50% of the estimated cost.

or

- (c) One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- 3. The Tenderers must have adequate manpower, materials, Machineries and other resources required to execute this work within stipulated time.





## **GENERAL CONDITIONS OF CONTRACT**

(To be attached with Technical & Commercial Part)

- 1. All relevant ISS & CPWD specifications will be followed during the course of work.
- 2. The Contractors will be responsible for providing medical facilities, accommodation, drinking water and other amenities to the worker employed by them to the site as per requirement of the labour at their own cost.
- 3. The quantities of work given in the bill of quantities may vary. No claim will be entertained for increase or decrease in quantities or elimination of items tendered.
- 4. The contractor will have to maintain at site a bound inspection book. Any extra item ordered by the Engineer in charge and the day to day instruction regarding the work shall be entered in that book.
- 5. No claim for idle labour under any circumstance will be entertained by the department.
- 6. The contractor or his authorised agent shall always be present at site while the work is in progress and at the time of measurement.
- 7. Payment will be made in running account system for continuous works. The bill will be submitted by the Contractor once in a month for substantial quantity of work done. The DR. RPCAU, Pusa is not bound to make monthly payment for works considerably lower than warrnted by the proportionate time.
- 8. All existing labour laws and regulations shall have to be followed by the contractor. The tenderers have to submit an attested copy of labour license under contract labour (Regulation & abolition) Act'1970 along with the tender.
- 9. Conditional tender may not be acceptable in the DR. RPCAU, Pusa.
- 10. All prevalent rules including minimum wages act revised from time to time will be binding upon the contractor and all the relevant labour laws shall have to be observed by them.
- 11. The contractor will have to maintain necessary records regarding payment of minimum wages of the labourers and exhibit before the officials of labour department and DR. RPCAU, Pusa as and when so required by them.
- 12. In case of any dispute, the decision of the competent authority Engineer-in-charge/Director (B&I)/(P&F) or the higher authority as the case may be will be final and binding.
- 13. The work will be carried out in protected area. Hence all the rules and regulations of the department which are enforced from time to time shall have to be followed.
- 14. Before submission of the tender, the tenderers shall acquaint themselves with the site conditions so that they may get an idea of the working conditions and incorporate all exigencies and cost effect in the quoted rates.
- 15. The contractor will have to co-ordinate their work with other agencies working in the area and no claim for delay in work due to idle labour on any account will be entertained.
- 16. Tenderer must deposit the required Earnest Money as mentioned in the tender notice in the shape of NSC duly pledged in favour of undersigned having Pledging order letter number of this office. No adjustment of pending dues lying with the department in any shape will be made towards earnest money. Earnest money is not acceptable by Cheque, Tender without the requisite Earnest Money will not be considered valid and hence rejected.
- 17. Experience certificates for similar type of works done previously must accompany the tender.
- 18. The competent authority reserves the right to distribute the work to one or more than one agency/ or reject any or all the tender without assigning any reasons thereof.
- 19. Permanent address for correspondence should be furnished in tender documents otherwise the tender will not be considered.

- 20. Rate may be quoted in percentage above or below, the estimated rates or in words and figures both.
- 21. Excess departmental materials issued by the department shall be returned to the department by the agency otherwise double cost of materials shall be recovered from the agency.
- 22. The contract shall be eventually drawn on F2 Form General and special conditions of contract shall be read with the terms and conditions laid down in F2 Form, but for anything mentioned to the contrary in F2 Form, provision laid down in General Conditions of contract /special conditions of contract shall prevail.
- 23. A tenderer shall (on a separate sheet) give a brief description of works previously executed by him. After the tender has been opened, a tenderer may be required to submit details of such works along with manner of their execution and/or any other information that will satisfy the **DR. RPCAU**, **Pusa** that the contractor has adequate competency to execute the work required to be carried on under these specifications. Tenderers not meeting qualifying criteria of NIT shall be excluded from consideration for the award of the work.
- 24. Tender should satisfy that the statements as required along with the tender documents are correct and complete in every respect. Any inaccuracy detected later shall vitiate the contract and make the contractor liable to be proceeded against.

#### 25. FORCE MAJUERS.

- i) If during the continuance of the contract either of the parties or both are prevented from fulfilling the obligation under the contract due to force majuers such as fire, act of nature/ war, rids, political disturbance, military operation or such other circumstances beyond the control of the party/parties, the date of fulfillment of their obligations shall be extended in proportion to the time during which such circumstances prevail.
- ii) The party affected by the force majuers as detailed above shall immediately notify in writing the other party of the beginning of such circumstances as also the cessation thereof.
- iii) In case of force meajures as detailed above the parties shall immediately meet for consultation and shall work out the measures to be taken.
- 26. In Super session of the clause in F-2 contract in respect of arbitration the civil court of Samastipur shall alone have exclusive jurisdiction to decide any differences/ disputes claims for and against DR. RPCAU, Pusa or the contractor arising out of this contract.
- 27. Construction materials which will be used in the work like tarfelt bricks, sand stone chips, paints, quality and colour of distemper/snowcem and quality of wood will be approved by the Engineer-in-charge of the work.
- 28. No work beyond agreement shall be extended by the Contractor unless specifically ordered by the Engineer-in-charge in writing the claim for such work shall be submitted regularly in every month. If the claim is not received in the month in which it relates, it is treated as barred any be disallowed.
- 29. Income tax shall be deducted from each bill as per rules.
- 30. GST shall be deducted from each bill as per rules.
- 31. Contractors shall have to furnish payment certificate, taxes of the materials consumed in the work other side towards royalties and cess shall be made as per rule act.
- 32. Deduction of five percent of the gross amount of the bill be made from the running bills so as to made the total security deposit at ten percent of cost of work. No part of these security deposit shall be refunded until the work is fully completed and the final bill disposed of. Fifty percent of the amount of security deposit shall be released after six months of satisfactory completion certificate and satisfactory performance of work by the competent Engineer-in-charge.

#### SPECIAL CONDITION OF CONTRTACT

(To be attached with Technical & Commercial Part)

#### 1. SECURITY MONEY.

The contractor shall have to deposit 10% of the contract value as security deposit, 5% being the initial security, which shall have to be furnished in shape of N.S.C. duly pledged in favorer of undersigned within 10 days of issue of written order from the Engineer-in –charge for execution of agreement, failing which his tender shall be rejected and earnest money will be forfeited. The balance 5% shall be recovered from the running account bill.

#### 2. IDLE CHARGES.

No charges for idle man, machine, plant and equipment will be allowed to the agency for some reason or the other beyond the control of the department.

#### 3. TAXES

The rates should be quoted including all taxes on all commodities. GST as levied by as per rules.

#### 4. MAINTENACE PERIOD AND REFUND OF SECURITY:-

Maintenance period will be counted from the date of completion of work. This period will be twelve months, thereafter security will be refunded after getting a certificate from the Engineer-in-Charge that the work has been done as per drawing and specification.

5. The Contractor will have to make arrangement for water both for drinking purpose of the labours and for construction purpose both at their own cost. However, if the work site is located at any convenient location where water supply system of the DR. RPCAU, Pusa is already operative and if under such precondition water is arranged by the DR. RPCAU, Pusa at any one point, water charges shall be recoverable @ 0.80% percent of gross bill value of work done.

#### 6. EXTRA WORK

Any extra work done by the Contractor will be paid as per schedule of rates prevalent in that area or if no such rates exists in the schedule, the rates to be mutually agreed upon before taking up the extra works as per analysis by the E/I. Before taking the work of extra item, it must be got approved by the competent authority to avoid subsequent dispute and delay in decision.

#### 7. DATE OF COMMENCEMENT.

The date of commencement of work will be considered from the date of work order given to the contractor in writing.

#### 8. VARIATION IN QUANTITIES OF WORK.

University does not take guarantee of work under each item of schedule. The quantity indicated in the Bill of quantity for items of work may increase or decrease for which no claim will be entertained by the DR. RPCAU, pusa.

## 9. LIQUIDATED DAMAGE.

For any delay in completion of work liquidated damages will be charged as per relevant clause of F2 Agreement.

## 10. MONTHLY PAYMENT.

The Contractor shall submit monthly bill for work done to the E/I and the department will make monthly payment to the contractor after, checking of bill provided the fund is available. No interests will be paid in case of delay in any payment but delay in any payments but delay in payment shall entitle the Contractor for consequential extension of time.
