- Objectives and scope of the requirement: The broad objectives of the EOI to establish 1:1
 Uncompressed and unshared Internet Leased Line of Bandwidth 100 Mbps, (Redundant
 Connection) at Pt. Deen Dayal Upadhyay College of Horticulture & Forestry, Piprakothi,
 E.Champaran. It covers
 - I. Establishment of internet connection at Pt. Deen Dayal Upadhyay College of Horticulture & Forestry, Piprakothi, E.Champaran. Location Co-ordinates are Latitude 26.542897, Longitude- 84.941565 at last mile of RF/Fibre. Preference will be given for fibre last mile.
 - II. Liaising with DOT/others for obtaining Point to Point Connectivity between ISP node and PDDUCoH&F, Piprakothi,RPCAU within the committed time frame.
 - III. Minimum 12 numbers of Static IP address.
 - IV. Router, MUX/Modem and any other hardware required to be provided by Bidder.
 - V. Configuration of the required Hardware (Modem, Router etc.) and software
 - VI. Any statutory requirement for installation and working of all equipment of the ordered connectivity shall be responsibility of the bidder.

In second stage of billing, the bid will be invited from at least three shortlisted firms with well-developed Bid having Technical Bid and Financial Bid based on the technical discussion during PPT presentation. For better transparency open tender may be invited depending upon the numbers of shortlisted firm during EOI.
