REVISED NOTICE FOR FRESHERS (2022-23)

In reference to our earlier **IMPORTANT NOTICE FOR FRESHERS (2022-23)** bearing No. 1093/Regr./RPCAU, Pusa dated 7th January, 2023, it is to inform that due to unavoidable circumstances, some changes have been made with respect to dates for document verification and admission in respect of all the provisionally admitted candidates in various Bachelors'/Master's/Ph.D. Programmes at RPCAU, Pusa for the Academic Session 2022-23 (first semester) are given below. Other details are as usual.


It is also to be noted that those students whose testimonials/certificates are found improper or not as per requirement of admission process, will be liable to be cancelled and/or rejected. Candidates passed out from listed private agricultural universities/colleges not accredited by ICAR, even though affiliated to public funded/Govt. institutions will not be considered for admission who has provisionally admitted through ICAR counseling.

It is further directed to all the admitted students of 2022-23 should come with full preparedness to stay in hostel and go for physical classes at different campuses after admission. **It is mandatory to all students to come with Covid medical certificate of 72 hrs. RT-PCR Report from recognized hospital/centres.**

In general, it should be avoided to bring parents at the time of verification of documents/final admission. However, if they are coming, they are directed to apply for accommodation in RPCAU, Pusa, which will be allotted on first come first basis. Rest other have to stay in Samastipur or guest house as nearby to RPCAU. The request mail must be sent to kisanghar@rpcau.ac.in for parent's accommodation purpose.

It is mandatory to have blazer for attending classes, for which a stall will be arranged on the date of admission, students may purchase blazer after paying a sum of Rs. 2500/-

Note: Bike will not be allowed in the academic premises, however students may use bicycle for his/her own purposes.
