1. This is with reference to **Subject Matter (Practical Test)** and **Written Examination** held for the post of **Cook** on 21st **September 2019** at **10:00 AM** at IHM, Hajipur, Vaishali and on 22nd September 2019 at 10:00 AM at Dr. Rajendra Prasad Central Agricultural University, Pusa, Samastipur, Bihar respectively.
2. The List of Eligible/Provisionally Eligible Candidates on the basis of screening of applications who are being called for Document Verification is placed below at **ANNEXURE - 1** for information of all concerned.
3. **All the candidates whose name is there in the list** as per ANNEXURE - 1 given below are advised to **report to the Deputy Registrar (Recruitment)** of the University at the below given address on **5th November 2019 (Tuesday) at 10:30 AM** for verification of their documents related to Qualification, Experience etc.:

4. **The candidature of all candidates** whose name is there in the list at **Annexure 1** is **PROVISIONAL** subject to their being found eligible in all respects. The candidates would be required to produce the original testimonials/certificates/documents in support of their claims relating to age, educational qualifications, community, experience, physical disability (*as applicable*) etc. on **5th November 2019 (Tuesday) at 10:30 AM** at the address mentioned above at Para 3.

IMPORTANT NOTE:

- i. It may be noted that since the total number of posts of Cook advertised were 8 (Eight) [04 - UR, 02 - OBC, 01 - SC and 01 - EWS], therefore, preference (*in order of merit*) will be given to the candidates, subject to the condition that they are found eligible (*as per the minimum eligibility norms as published in the Advertisement No. 01/2019 dated 3rd March 2019*) upon verification of their original documents as mentioned in Para 4 above.
- ii. The candidates whose name is there in the list and who **in order of merit** would be found Eligible (*as per the minimum eligibility norms as published in the Advertisement No. 01/2019 dated 3rd March 2019*) in all respects **subject to number of post(s) advertised** would be selected and issued Offer of Appointment accordingly.
- iii. The appointment of a candidate shall be subject to the verification of antecedents, educational qualifications, experience, caste certificate and medical fitness etc.

5. **All the candidates are required to bring with them the following original testimonials/certificates/documents failing which their candidature shall not be considered for final selection:**
- i. Matric or equivalent certificate in support of Date of Birth
 - ii. Certificate of Education/Professional Qualification in support of Minimum Eligibility and qualification claimed by the candidate in the application form (*Matriculation onwards*)
 - iii. Experience Certificate (Original mandatory)
 - iv. *Caste Certificate in the prescribed format issued by the Competent Authority.
 - v. **“No Objection Certificate (NOC)”** from the present employer, if in service.
