**UNIVERSITY MOP-UP ROUND ADMISSION-2021-22**

There are few vacant seats in various disciplines for the Academic Session 2021-22 in RPCAU, Pusa under UG, PG and Ph.D. programmes.

Aspirants for Undergraduate/Postgraduate and Ph.D. degree programmes for all the disciplines for the Academic Session 2021-22 (First Semester) are advised to apply with one to three choices, as applicable, of subjects on our portal ([www.rpcau.ac.in](http://www.rpcau.ac.in)) till 26<sup>th</sup> January 2022 (11:59 pm). The list will be uploaded as per their All India ICAR Rank on 29<sup>th</sup> January 2022 before midnight (11:59 pm) and the admission will be carried out through online on 31<sup>st</sup> January 2022. The admission will be in the same category which is mentioned on the tentative list, depending on vacant seats/leftover seats available after admission rounds from ICAR admission (I, II, III & mop-up round) process. The candidates applying for seat in mop-up round for UG/PG/Ph.D. are instructed to apply only in the disciplines/subject where they had appeared in ICAR examination and/or in the group of concerned subjects. Those aspirants who have not appeared in ICAR examination (AIEEA-2021) need not to apply, and if applied their candidature will be rejected and cancelled. In this case, Processing Fee will also not be refunded.
