OFFICE ORDER

On the recommendation of Price fixation committee in its meeting held on 22.07.2022 and duly approved by the Hon'ble Vice Chancellor, RPCAU, Pusa as per approved of rate fixation of Incubation & hatching of chicks from hatchable eggs, file no. 12/2013 at the page no. 36/N., dated 25.07.2022, is fixed as mentioned below which will be effective from the date of issue of the order.

Terms & conditions:

1. The charges will be taken only on the hatched chick's basis not egg set basis.
2. Hatchability may vary depending on various uncontrolled factors at the risk of stakeholder/farmers.
3. The stakeholder/farmers will be allowed to observe inside the hatching room if desire, once in a day with prior intimation & permission and strict compliance of the hygienic entry condition laid down in hatchery unit, APRI, RPCAU, Pusa.
4. The stakeholder/farmers will collect hatched chicks from hatchery unit, Pusa on the day of hatching.
5. If stakeholder/farmers delay in collecting DOC then extra Rs. 1.0/chicks/day will be charged.
6. Poultry Unit, APRI, Pusa will not be held responsible, if mortality or any abnormal symptoms appeared in DOC.
7. An undertaking in the prescribed format of the point 1 to 6 to be given by the stakeholder/farmers.

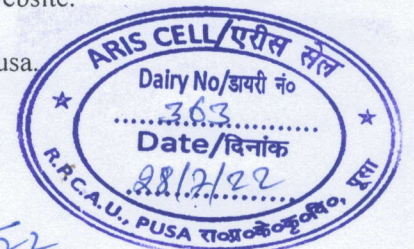
